

DUST CONTROL PROGRAM INFORMATION SHEET

Becker County Highway Department will again offer the Dust Control Program for our gravel-surfaced roads. The dust suppressant used is one application of liquid magnesium chloride. Magnesium chloride is hygroscopic, meaning that it attracts moisture from the atmosphere and its surroundings. This tendency helps to keep gravel surfaces damp and the dust down. As a result, when applied to the road the surface becomes compact. Over time, the chemical penetrates the surface adding a stabilizing effect, which holds the aggregate together in the gravel surface resulting in decreased dust for adjacent residents.

Becker County **CANNOT** guarantee that the suppressant will last the entire season, variables such as weather and traffic volumes affect the chemical's performance. During dry periods watering the treated area will re-activate the dust suppressant. Heavy rains may wash the suppressant from the road surface. It is recommended that "Dust Control" signs be placed at the beginning and end of the section to notify the blade operators of the application. Repeated applications year after year increase the chemical's performance tremendously in most cases. Blading can be done to the application area, but care must be taken not to bring any non-treated material into the treated area.

Due to budget constraints the County will **no longer** be cost-sharing with the landowner on County roads in every case. However, in a case where the residents cooperatively treat 50% or more of a County road the County may treat the remaining road segment in order to reduce maintenance costs. These situations will be handled on a case by case basis. In all other situations the entire cost is the responsibility of the landowner for both Township and County roads. If you live on a township road and you are interested in participating, please contact your town board so they are aware of the application and plan their maintenance and improvements accordingly. **There is a minimum application length of 500 feet for either road type.**

The attached Cost Estimate Sheet for 2010 will give you an estimated price for the length you would like to apply. It is the property owner's responsibility to mark the area to be treated. **All County Roads are estimated for an application width of 20 feet, not the total road width. Township roads are estimated for the application width chosen, not the total road width.**

If you are interested please complete the attached form and provide a sketch on the back if you would like. The application and a deposit equal to 50% of the application cost is due in the Becker County Highway Office, 200 State Street East, Detroit Lakes, MN 56501 no later than **May 14, 2010.**

The final billing for that balance will be issued based on the actual gallons applied. This will be due and payable upon receipt of the statement. The application of the magnesium chloride will be some time after June 11, 2010
